EXPLANATION.

This Amendment No. 6 to Schedule 13D ("**Amendment No. 6**") relates to shares of Ordinary Shares (as defined below) of the Issuer (as defined below) and is being filed on behalf of the Reporting Persons. This Amendment No. 6 amends and supplements Amendment No. 5 previously filed with the SEC (as defined below) on July 7, 2021 ("**Amendment No. 5**"), Amendment No. 4 previously filed with the SEC (as defined below) on May 13, 2021 ("**Amendment No. 4**"), Amendment No. 3 previously filed with the SEC (as defined below) on April 7, 2021 ("**Amendment No. 3**"), Amendment No. 2 previously filed with the SEC (as defined below) on February 8, 2021 ("**Amendment No. 2**"), Amendment No. 1 previously filed with the SEC (as defined below) on December 14, 2020 ("**Amendment No. 1**"), and the initial Schedule 13D previously filed with the Securities and Exchange Commission (the "**SEC**") by the Reporting Persons on July 16, 2019 (the "**Initial Schedule 13D**"), together with Amendment No. 1, Amendment No. 2, Amendment No. 3, Amendment No. 4, Amendment No. 5 and this Amendment No. 6, the "**Schedule 13D**", with respect to the Ordinary Shares, no par value (the "**Ordinary Shares**"), of Spark Networks SE, a European stock corporation (*Societas Europaea*, SE) with its corporate seat in Germany (the "**Issuer**"). Except as specifically provided herein, this Amendment does not modify any of the information previously reported in the Schedule 13D.

ITEM 5. INTEREST IN SECURITIES OF THE ISSUER.

Paragraphs (a), (b) and (c) of this Item 5 are amended and restated as follows:

(a) and (b) As of the date of this Schedule 13D, the Partnership may be deemed to beneficially own 2,110,353 ADSs, representing approximately 8.1% of the total outstanding Ordinary Shares, which ADSs are held directly by the Partnership (the "**Partnership Shares**"). The Partnership has sole voting, investment and dispositive power with respect to the Partnership Shares.

As of the date of this Schedule 13D, the General Partner may be deemed to beneficially own the Partnership Shares. The General Partner has sole voting, investment and dispositive power, through its control of the Partnership, with respect to the Partnership Shares.

(c) Information with respect to all transactions in the Shares beneficially owned by the Reporting Persons that were effected during the past sixty days is set forth on Annex I attached hereto and incorporated herein by reference.
